Multi-Factor Authentication

Multi-factor authentication (MFA) is a multi-step login process requiring more than just a password. It prevents unauthorized access if a password is compromised. Bridge Ignite, will enable MFA for users with verified email and mobile numbers, and the management of these details will be held by the account administrator.

Enabling MFA:

Upon initial build set-up, MFA can be configured on which will allows the account administrators to manage the required settings. Once enabled current users receive an email notification upon MFA activation. When logging in, users must enter their username, password, upon validation a passcode will be sent to the cell phone number on file and the user will be required to enter the required code for access.

Disabling MFA:

Multi-Factor Authentication (MFA) is recommended once enabled. However, if there is a request to disable MFA for a user account, this will be managed by the account administrator. Once enabled, the user will be able to log in without a passcode.
